Thames21 Charity Place

Terms and Conditions

By applying for a Thames21 (“T21”) charity place at Regatta London (otherwise also referred to as the “Event”) organised by a third party (the “Event Organiser”), you accept and agree to abide by the following terms:

Taking part

1. I understand that the event is not organised by T21, but by the Event Organiser. It is my responsibility to read any terms and conditions issued by the Event Organiser, including Race Rules, and to comply with these.
2. When taking part in the Event, I understand that I must comply with all security provisions, health and safety provisions and other directions or requirements notified to me by T21 or the Event Organiser in connection with the Event.
3. I confirm that I am medically fit and that I participate in the event at my own risk. I understand that the London Crossing and Big Ben are challenges covering 12 or 14 miles in distance and I am required to have the relevant experience, knowledge and skill to be safe during the event. T21 will not be held responsible for injury or illness resulting from my participation and if at any time during the Event the organisers are concerned about my competence to be safe on the river, they may instruct me to leave the water, and in this case no refund will be provided.
4. In taking part in the event, I understand that:
 - a. I am required to provide my own equipment for this event
 - b. I will wear one of the Race Numbers
 - c. I will follow the Race Rules published by the Event Organiser
 - d. I will follow the reasonable directions of Event Organiser and/or their authorised representatives.
5. All T21 Participants must be aged 16 or over by the Event Date.
6. I acknowledge that any registration fee is non-refundable, and that charity places in the event are non-transferable. The registration fee does not contribute towards my fundraising target.
7. I understand that, having applied for a Charity Place, T21 may need to notify the Event Organiser that I will be taking part, and share limited personal information so that the Event Organiser can contact me to confirm my registration for the event. I understand that it is my responsibility to complete the Event Organiser’s registration.

8. I understand that once I have registered for the event, I must make every effort to participate in the event. I must contact T21 if I am unable to take part in the event and forward any money raised to T21.
9. When taking part in the event, I understand that I must refrain from behaving in any way which may cause offence or damage the reputation of T21, specifically I must not do or say anything that may:
 - Be considered obscene, immoral, harmful or offensive according to generally acceptable standards
 - Offend against the normal standards of decency
 - Encourage or incite the commission of crime or public disorder
 - Endanger public safety
 - Encourage, in whatever manner, behaviour which promotes disparaging views or behaviour relating to an individual or group's colour, race, nationality, ethnic or national origins, disability, sex, sexual orientation, marital status, religion or age.
10. When taking part in the event I understand that I must not make any political statements.
11. When taking part in the event, I understand that I must not overtly advertise or promote the goods or services, name or brand of any third party or display or procure the display of any advertising or other promotional materials for any third party's goods and/or services, name or brand.
12. When taking part in the event, I understand that I must not cause damage at any of the locations of the event.
13. I understand that I must avoid the use of single-use plastic during the event in order to help protect the environment.

Fundraising

1. I will use my best endeavours to raise money for T21 in connection with my participation in the event and, in particular aim to raise at least the specified fundraising target if I have accepted a Charity Place. I understand that Gift Aid doesn't count towards my fundraising target.
2. I understand and will make clear to those who support my fundraising that any money I send into T21 will be treated as a donation and used for T21's work. Donations are not generally refundable, even if I fail to take part in or withdraw from the event.
3. Any fundraising I undertake in connection with my participation in the event will be for T21 only (applicable to Charity Place participants) and I will forward all monies donated to the Charity either by cash, cheque, or via an online giving provider no later than four weeks after the event.

4. I will only use lawful means to fundraise for T21 and will not bring the charity's names into disrepute.

Photos

I understand that there may be photography at the event and I grant permission for T21 to use photographs, motion pictures, quotes, or any other record of my participation in my chosen event for the purpose of marketing future events online and on print materials.

Confirmation

I confirm I have read, understood and agree to all the terms and conditions set out above, and understand T21 may terminate our relationship if I am in breach of any of the terms and conditions.

We recommend that you print and keep a copy of this agreement with a note of the date on which you accepted its terms and conditions.
